## PMG Fonds Management AG shifts fund administration to the XENTIS cloud from Profidata

The independent PMG Fonds Management AG (PMG) has selected the XENTIS investment management system from Profidata Group (Profidata). The Swiss fund manager relies on XENTIS cloud (Xcloud), Profidata's service for financial service providers, who wish to outsource their IT operations.

XENTIS will be implemented as central application for administration, accounting and monitoring of the Net Asset Values (NAV's) of the investment funds. The NAV's will be calculated daily by XENTIS for publication over PMG's internet portal. In addition, emphasis is placed on the handling of corporate actions and fee calculation. The supply of XENTIS with security and market master data over an interface provided by SIX financial information is also part of Xclouds' scope of services. XENTIS provides the functionality for both, annual and client reporting. With the integrated query module PMG's system-users can perform sophisticated data retrievals. PMG uses the system as a hosted service on a secure data center which is compliant with the guidelines of the Swiss Financial Market Authority (FINMA).

Dr. Raoul Dobal, Member of the Management Board of PMG Fonds Management AG explains the reasons for this decision: 'Three criteria were decisive for Xcloud: XENTIS is flexible and can therefore be adapted quickly to our requirements, Profidata's employees understand our business, and their comprehensive services are economically attractive.'
